### **IAPMO Solicits Proposals for 2012 UPC, UMC**

**Ontario, Calif. (Oct. 29, 2009)** — The International Association of Plumbing and Mechanical Officials (IAPMO), publisher of the *Uniform Plumbing Code (UPC®)* and *Uniform Mechanical Code (UMC®)*, is calling for formal code proposals toward the development of the 2012 editions of these American National Standard designated model codes.

The code proposal form, as well as proposal instructions and background on IAPMO's ANSI-accredited consensus development process, can be found at <http://www.iapmo.org/Pages/CodeDevelopment.aspx>. All proposals recommending new text, revised text or the deletion of text must be written in legislative format and clearly state the reason behind the recommendation.

No proposals will be accepted after the 5 p.m. EST/EDST deadline on Feb. 1, 2010.

Introduced in Los Angeles in 1928 and formally published as the *Uniform Plumbing Code* in 1945, the *UPC* is developed to govern the installation and inspection of plumbing systems as a means of promoting the public's health, safety and welfare. Later published by IAPMO in 1967, the *UMC* provides the same governance for mechanical (HVAC, combustion, exhaust, refrigeration) systems. Developed and subsequently republished at the conclusion of each three-year code cycle, the *UPC* and *UMC* are designed to provide consumers with safe plumbing, heating and mechanical systems while, at the same time, allowing latitude for innovation and new technologies.

IAPMO employs a consensus development process accredited by the American National Standards Institute, gathering the largest assembly of plumbing and mechanical experts in the world at its annual education and business conference and technical committee meetings, enabling anyone — members and non-members alike — to have a voice and a vote on proposed changes to the code. The 2012 editions of the *UPC* and *UMC* will mark the fourth time these codes have been developed in this manner.

IAPMO urges its members and other interested parties to get involved in the code development process to ensure effectiveness in preserving the public health, safety and welfare through strict governance of the Uniform Codes. Installers, plumbing and mechanical officials, the construction industry, engineers and manufacturers all benefit from a cooperative effort in developing codes.
